RIGHT TO ACCESS: By exercising this right, it is requested that the right to access the Personal Data Processing is freely granted within a maximum period of one month from the receipt of this request, that all the information related to article 15 of the GDPR be issued by post to the address indicated above, in a legible and intelligible manner and within the period indicated.

RIGHT TO RECTIFICATION: By exercising this right, it is requested that the right to rectification is freely granted, in accordance with that stated in article 16 of the GDPR. It will be necessary to provide the corresponding proof.

RIGHT TO ERASURE: By exercising this right, it is requested that the right to erasure, or the right to be forgotten, is freely granted, in accordance with that stated in article 17 of the GDPR. It will be necessary to provide the corresponding proof.

RIGHT TO RESTRICTION OF PROCESSING: By exercising this right, it is requested that the right to restriction of processing indicated is freely granted, in accordance with that stated in articles 18 and 19 of the GDPR. It will be necessary to provide the corresponding proof.
